I'd like to thank all of our City employees who worked outdoors during the frigid weather, especially our First Responders from Police and Fire Departments, as well as our Street and Water Department crews.

Secondly, as you may be aware, the Joliet City Council voted last November to increase money set aside for street repairs from \$2.5 million to over \$16 million dollars, as well as raise the budget for sidewalk repairs from \$250,000 to \$1.2 million. As a result, Joliet residents should expect to see significant infrastructure improvements throughout the City.

Lastly, the ongoing water project continues with the City of Joliet committed to replacing every water main constructed prior to 1970, as well as replacing all lead pipes throughout the City. This is a tremendous reinvestment in Joliet and will benefit all residents and businesses who choose to invest in our City. 

Financial Picture

The City of Joliet's 2023 Annual Budget was adopted on December 6, 2022, with \$597 million in spending for 2023 funds. As illustrated by the following chart, 39% of our spending is for government operations which includes police and fire protection, roadways, customer service personnel, and other administrative functions. Parking Operations Fund

16% of the budget provides water and sewer service. The remaining monies are for infrastructure projects or for funds with external legal requirement such as pensions. grants, and bonds.



Did You Know?

Only 13 cents of every dollar paid in property tax goes to the City. The remaining 67 cents goes to schools, park district, forest preserves, county, and township.







Welcome, New Partners

City of Joliet is an entitlement community recipient of the Community Development Block Grant (CDBG). As an entitlement community, the City has an opportunity to assist non-profit organizations create a positive community impact throughout Joliet.

This year the City is excited to welcome two new partners, Easterseals-Joliet Region and Will-Grundy Medical Clinic.



Mayor O'Dekirk, along with members of City Council, EMA, Fire, and Police, presented a CDBG-CV commemorative check in the amount of \$296,548.25 to Will-Grundy Medical Clinic on Wednesday, January 11, at Joliet City Hall. This funding assists efforts of non-congregate shelter costs due to the effects of COVID-19.

Mayor O'Dekirk and members of City Council presented a CDBG commemorative check in the amount of \$57,000 to Easterseals-Joliet Region on Wednesday, January 11.

Roadway Resurfacing Program

Due to a variety of factors, including a labor strike at local quarries and a nationwide cement shortage that limited the availability of construction materials, several streets that were scheduled to be resurfaced as part of the 2022 Roadway Resurfacing Program were unable to be completed during the 2022 construction season. For a complete listing of streets on the 2022 Roadway Resurfacing Program that will be resurfaced in 2023, visit: www.joliet.gov/resurfacingprogram.

Additionally, the Mayor and City Council have approved \$10.9 million for roadway resurfacing projects as part of the 2023 budget. This funding will be utilized to complete resurfacing projects in addition to the streets listed on the Roadway Resurfacing Program web page. Streets are currently being reviewed Citywide for potential resurfacing projects in 2023.

Roadway Reconstruction

Since 1982, the Department of Public Works has reconstructed neighborhood streets within the City of Joliet. These projects were previously completed through the City's Neighborhood Improvement Program and are now being completed through the Roadway Reconstruction Program utilizing Motor Fuel Tax (MFT) funds received from the State. Additional funding for street reconstruction projects is sometimes provided through the Community Development Block Grant (CDBG) program. Both residential and/or collector streets are reconstructed through this program. Roadway reconstruction includes pavement removal and replacement, the installation of storm sewer, new curb and gutter, new concrete driveway aprons, the installation of ADA ramps, and placement of sod in the parkway.

The 2023 Roadway Reconstruction Program includes streets from both the 2021 and 2022 Program where construction was delayed due to utility conflicts in addition to the streets included in the 2023 Program. The following is a listing of streets to be reconstructed as part of the 2023 Roadway Reconstruction Program:

- 1. Broadway Street (Marion Street - Jefferson Street)
- Cora Street (Frank Avenue Russell Street)
- Dekalb Street (Pleasant Street- Center Street)
- 4. Dora Avenue (Woodruff Road - Garvin Street)
- 5. Helen Avenue (Charity Avenue- Mills Road)
- 6. Parks Avenue (Elwood Avenue - Liberty Street)
- 7. Stone Street (Hickory Street - Center Street)
- 8. Wallace Street (Pleasant Street - Center Street)
- 9. Walsh Avenue (Douglas Street - Taylor Avenue)
- Washington Street (York Avenue Eastern Avenue)

Grand Prairie Water Commission



The communities of Channahon, Crest Hill, Joliet, Minooka, Romeoville, and Shorewood have joined together to proceed with formation of the Grand Prairie Water Commission (GPWC). The mission of the Grand Prairie Water Commission is to provide a sustainable, reliable, and high-quality water supply for the member communities by 2030 and beyond in order to support public health, safety, economic interests, and quality of life.

All six member communities are currently working together to design the water transmission system required to bring water from Chicago to the region. Current activities include determining the transmission main route and locations for pumping facilities, storage tanks, and connections to each community, as well as preparation of design documents for the improvements. Construction is anticipated to commence in 2024. Customers will begin receiving Lake Michigan water in 2030.

Fix a Leak Week - March 13 - 19, 2023

Early detection of water issues can save you money and prevent potential damage to your property. Water usage is not always visible to us. Plumbing runs underground, behind walls, through floors, and through ceilings. Don't forget there are also hidden devices we don't often think about such as

whole house humidifiers and water lines to ice cube makers in our refrigerators. Two easy ways to observe #FixALeakWeek

- 24/7 access to monitor water usage hourly, daily, weekly, or monthly
- · Set alerts if usage is nearing previous month usage
- · Set vacation alerts
- Find possible leaks quickly by monitoring usage during overnight hours or while gone

Dye test your toilets

- · Add a few drops of food coloring to your toilet tank
- · Wait 15 minutes
- If any color shows up in the bowl, you need to check the seals and flapper
- Do you have a toilet from prior to 1992 that is a 3.5-gallon flush or more? If yes, contact Public Utilities at (815) 724-4220 and ask about our toilet rebate program.

Toilets are the #1 culprit of household water loss. Make it a habit to test them in the spring and fall as part of your regular maintenance checklist.

Attention, Joliet Landlords!

The City of Joliet has passed an amendment to the Systematic Rental Inspection Program that affects all landlords. If you own property that you do not reside in and someone else does, this is considered a rental property, per ordinance 8-152 (h). This new amendment requires you to register with the City of Joliet and obtain a license to operate rental property.

The registration form is available at **www.joliet.gov** under Permits and Forms. Once the City receives your registration form and the license fee of \$100, a license will be issued. It is the owner's responsibility to register and obtain the license.

Additionally, the new amendment requires all rental units to be inspected. This includes single family rental homes, two-unit homes where the owner resides in one of the units, and condo units that are rented out. You will receive a letter notifying you of the inspection date and time. Please be aware that it may take us some time to schedule this inspection, as we work through all the newly regulated properties. After you have completed your registration and obtained your license, you may continue to operate your registered rental as normal while waiting for your inspection to be scheduled. Hazardous Household & Electronics Collection

Waste Management offers a convenient special collection service called "At Your Door." This service allows residents to properly dispose and recycle common hazardous household and electronic items safely, easily, and responsibly. Items include automotive products, electronics, garden chemicals, household cleaners, paint products, along with needles, lancets, and more. Discarding Large Household Items

Contact Waste Management at (815) 280-7854 prior to placing large household items curbside on your regularly scheduled collection day for proper disposal instructions and program details.

Some items may need to be broken down, dressers/cabinets with wood/glass shelving removed and glass taped, furniture items such as carpeting/padding, couches, chairs, and mattresses may need to be wrapped to prevent moisture penetration. Items that are not properly contained, broken down, taped or wrapped, and get wet will not be collected. Visit www.wm.com for details.

Discarding Restricted Items

The following items are not part of the weekly Waste Management garbage collection program and require residents to schedule a special pick-up for a fee to have WM pick these items up. Call WM at (815) 280-7854 or residents can call a company of their own choice for a fee to pick up these items:

Charcoal/hot ash Dirt, stone, concrete, rock

Eviction/move out piles of belongings

Large automotive parts

Large qty construction/demo materials

Materials from floods and fires Permanent swimming pools

Residents should report any of the above items left anywhere on a property to the Information Desk at (815) 724-4005.

Discarding White Goods

White goods are large electrical goods used domestically. Contact Waste Management at (815) 280-7854 to schedule a collection pick-up before placing any type of white good item(s) curbside with your garbage. Accepted white goods are:

Air conditioners, Humidifiers, Chillers & Dehumidifiers

Ranges, Stoves, Ovens & Microwaves

Refrigerators & Freezers (Please remove doors before placing curbside for pick-up)

Washing Machines & Clothes Dryers

Water Heaters, Furnaces, Boilers & Heat Pumps (Must be drained of any water)

Note: The above services are available to residents that pay for municipal waste on their City of Joliet water and sewer bill.
