SUBJECT: REQUEST FOR AUTHORIZATION TO AWARD A CONTRACT FOR THE

JOLIET MINOR LEAGUE BASEBALL PARK - CONCRETE

BACKGROUND:

The City of Joliet has agreed with the Joliet Slammer's to replace the existing Joliet Minor League Baseball Park natural turf with synthetic turf as well as modify the field to accommodate other sports including soccer. The new synthetic turf field will also allow the Ballpark to host more games as well as non-sports related events. The City will pay for the cost of this work up front and be reimbursed from the Special Service Area Fund (\$50,000 per year) and the Waste Management community support contribution (\$100,000.00 per year).

This project will be completed under the coordination of the Construction Manager, Wight & Co., through several construction contracts for each trade involved in the field turf replacement project. This contract is for the completion of the concrete work and concrete related items for the field turf replacement.

This project was advertised on Tuesday, August 15, 2017, and Thursday, August 17, 2017. The Public Service Committee shall review this matter.

CONCLUSION:

On Wednesday, August 30, 2017 at 9:30 a.m., two (2) lump sum sealed bids were received for the Joliet Minor League Baseball Park Concrete Project. The bid summary is as follows:
