SUBJECT: REQUEST FOR AUTHORIZATION TO AWARD THE 2018 UTILITIES

RESTORATION PROGRAM PHASE II CONTRACT IN THE AMOUNT OF

\$310,825.00 WITH P.T. FERRO CONSTRUCTION COMPANY

BACKGROUND:

The 2018 budget allocates funds for contracted restoration services in areas excavated by the Department of Public Utilities for water and sewer system repairs. Specific Contract work activities include repair and restoration of sidewalks, driveway aprons, street pavement, curb and gutter, and parkway turf grass. The Contract is the second phase of the 2018 Utilities Restoration Program which continues until November 30, 2018. The Contract allows for a sixty (60) calendar day project duration for the initial list of work locations.

Advertisement for bids for the 2018 Utilities Restoration Program Phase II Contract was published in the Labor Record on Thursday, June 21, 2018. The Public Service Committee will review this matter.

CONCLUSION:

On Monday, July 9, 2018, at 9:00 a.m., four (4) sealed bids were opened for the 2018 Utilities Restoration Program Phase II Contract. The bid summary is as follows:

The low bid from P.T. Ferro Construction, in the amount of \$310,825.00, is 0.57% above the engineer's estimate and includes proper completion of all bid documents. Sufficient funds exist utilizing the Water / Sewer Operating Fund / Concrete / Sod Repair (Org 50080012, Object 524300, \$310,825.00).
