SECT	TION 1- Purpose of Agreement

SEC1	TION 2 – Power and Authority		
	I,, as Principal, do hereby represent that I an manager in and to that real estate located at commonJoliet, Illinois and I hereby authorize and grant to the C	nly knowi	n as
	my agent, the power to enter upon any area of the property which is commonly account public; specifically including but not limited to common hallways, stairwells, stagrounds, garages, and parking lots. I grant to the City of Joliet full power and upon such common areas and to speak with any and all persons upon such common to remove from such common areas any and all persons who may be upon the preconsent or authority or who may be engaged in improper or illegal activities. I grant Joliet full power and authority to remove from the premises persons about who reasonable suspicion of engaging in criminal activity or a reasonable suspicion abbelieve may commence shortly to engage in criminal activity.	aircases, authority to mon areas emises wint to the Control they ha	open to go and thout ity of ive a
b.	I authorize and direct the city of Joliet to approach persons located upon the prem		

premises as tenant, employee, or customer. I authorize the City of Joliet to arrest any and all persons upon the premises if they refuse to leave the premises, unless such persons have authority and consent to be upon the premises. The City of Joliet, as my agent, shall have the power to sign criminal complaints against non-residents who are trespassing upon the premises

or are engaging in criminal activities or improper conduct.

d. The City of Joliet is authorized to direct its police officers to speak with persons upon the property at Joliet, Illinois and determine if such persons			
are lawfully patronizing the premises or have other authority or consent to be present. The City police officers are empowered to direct unauthorized persons to leave the premises and not to return unless they have lawful business to conduct on the premises. The police are authorized and empowered by me to arrest persons who refuse to leave the premises who are present without authority and who return without permission. Such police officers are empowered to sign criminal complaints for trespass against individuals who are upon the premises without consent or authorization.			
SECTION 3 – Effective Date of Agreement			
<ul> <li>a. This agreement shall be in full effect and legally binding upon such time as signed and will be certified by each party.</li> <li>b. The Chief of Police of the City of Joliet will retain the original signed agreement and will be responsible for circulating such agreement for purposes of signature and record.</li> </ul>			
<ul> <li>a. This agreement shall remain in full force and effect and shall terminate ten (10) years from its effective date.</li> <li>b. This agreement is also terminable by either party upon 24-hour notice, in writing, to the other party.</li> </ul>
