Award of Price Agreements for the 2021 Street Maintenance Materials Contracts

- a) City of Joliet Aggregate Price Agreement Contract
- b) City of Joliet Bituminous Patching Materials Contract

## **BACKGROUND:**

The 2021 City of Joliet Budget allocated funds to support the maintenance of the City Roadways including aggregate, hot mix asphalt patching, and cold patch materials. The Aggregate and Bituminous Patching Materials Contracts are a part of this program. These projects were advertised on Thursday, March 11, 2021.

# **CONCLUSION:**

On Monday, March 29, 2021 at 10:45 a.m. and 11:00 a.m., four (4) sealed bids were received for the City of Joliet Aggregate Contract and four (4) sealed bids were received for the City of Joliet Bituminous Patching Materials Contract. The Unit Price Bid Summary is as follows:

The fourth bidder was Green Dream International which is based out of Pennsylvania. Local suppliers are necessary for this contract as City forces pick up and haul the necessary materials.

The proposal explains that the City will do the hauling of the materials with City-supplied trucks. The City will enter into contracts with all of the above material suppliers. The City will purchase materials based on job location (using a haul rate of \$0.65 per ton mile), product availability, and what serves

the best interest of the City.

It is estimated that the City of Joliet will require approximately 19,000 tons of Aggregate for use by the Street Department and the Water & Sewer Department. In addition, it is estimated that the City of Joliet will require approximately 3,100 tons of Bituminous Hot Mix and 400 tons of Cold Patch Mixture for use by the Street Department and the Water and Sewer Department.

Sufficient funds exist for the Joliet Aggregate Contracts in the Public Works Roadways Street Repair Materials Fund (Org 09029000, Object 536107, \$59,400.00) and the Water & Sewer Operating Fund (Org 50080012, Object 536107, \$165,000.00).

Sufficient funds exist for the Bituminous Patching Materials Contracts in the Public Works Roadways Street Repair Materials Fund (Org 09029000, Object 536107, \$67,000.00) and the Water & Sewer Operating Fund (Org 50080012, Object 536107, \$169,000.00).

## **RECOMMENDATION:**

Based on the above, it is recommended that the Mayor and City Council take the following actions:

- 1. Enter into the City of Joliet Aggregate Price Agreement with Lafarge Aggregates, Boughton Materials, and Vulcan Materials at the unit prices noted above.
- 2. Enter into the Joliet Bituminous Patching Materials Price Agreement with Joliet Asphalt, P. T. Ferro Construction Co., Gallagher Materials, and D Construction at the unit prices listed above.
