USE OF COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS

Pursuant to the United State Department of Housing and Urban Development (HUD) regulations, the City of Joliet prepared and submitted an Annual Action Plan every fiscal Year. The Annual Action Plan describes the resources available and the proposed use of those resources to meet the community development, affordable housing, and homeless priority needs as outlined in the City’s Five-Year Consolidated Plan 2020-2024.

The City’s Annual Action Plans and the Five-Year Consolidated Plan are available for review at the City Hall located at 150 W. Jefferson Street in Joliet. Notice is hereby given that the City of Joliet is proposing to substantially amend the budget of its previously published Program Year 2023 Annual Action Plan to reallocate prior year balances to newly proposed projects.

The following budgets will be increased:

PY 2022 \$34,000.00 to Easterseals Public Facility Improvements.
PY 2023 \$650,152.00 to City of Joliet Infrastructure Improvement

The following budgets will be reallocated, and the projects will be cancelled:

PY 2021 \$250,000.00
PY 2022 \$28,000 Demolition

The following budgets will be reduced:

Senior Housing Repair (PY 2021) by \$35,000
Boys and Girls Club Facility Improvements (PY 2021) by \$27,622.55
Senior Snow Shovel (multiple years) by \$31,060
CDBG Administration (multiple years) by \$254,827
Other balances by \$57,642.45
